NOTICE INVITING REQUEST FOR PROPOSAL (RFP) FOR Conservation, Restoration and Digitalization of manuscripts at Mithila sanskrit snaatakottar adhyayan sodh Sansthan Darbhanga. Bihar

Bihar State Educational infrastructure Development Corporation (BSEIDC), Patna invites RFP from reputed Consultants for Empanelment on BSEIDC Panel through e-procurement process from Reputed Architects and firms on double bid system for the projects to be taken by BSEIDC. The empanelment of Consultant is proposed in different categories based on, amount other things, their experience, capabilities etc.

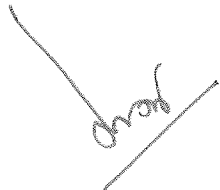
2. Scope of Work:-

The scope of this project is to Conserve important Manuscripts/Historical Records/Archival Collection including Dusting, fumigation, Pagination, De-binding, Chemical cleaning, De- acidification, Tissue Lamination and Archival binding, preserved in Mithila sodh sansthan, Darbhanga and to give them new lease of life. The project, therefore, comprises of tissuelamination (both sides), which includes guarding, binding, covering and paging of records to appropriate workflows for the activities involved in order to maintain the system in future.

The following broad scopes of work have been outlined: -

- Tissue conservation of Archival records and Rare Books preserved in the collection of Mithila Sodh Sansthan, Durbhanga, Bihar.
- All the materials required for conservation of Archival records and Rare Books will be supplied by the vendor.
- Development of work flow module for tissue conservation of public records related activities.
- Print out data entry summary of each record volume would be submitted for acceptance and sign off purpose with concerned official
- Providing Manpower for Supervision, Coordination, MTS, and non-skilled personnel for operating and Management of Record rooms.

Beltron bid processing fee as appeared on the e- tendering website:- www.eproc2.bihar.gov.in & bid document cost as mentioned is mandatory to be paid through e- payment mode i.e " internet payment gateway (Credit/Debit card), Net Banking, NEFT/RTGS" (Bids along with necessary online payments must be submitted through e- procurement portal www.eproc2.bihar.gov.in before the date and time specific in the (NIT/Corrigendum). The department doesn't take any responsibility for the delay/ non-submission of Tender/ non-reconciliation of online payment caused due to non-availability of Internet connection Network Traffic Holidays or any other reason.
- IV. The required amount of Earnest Money Deposit is acceptable either in the form of online mode or Bank Guarantee (BG) in proper format issued by any Nationalized/Schedule Bank issued in favour of MD, BSEIDC, payable at Patna. The original Earnest Money Deposit will have to be deposited along with the hard copy of bid document in the office of BSEIDC as per tender schedule, failing which tender will be rejected. The Earnest Money deposited in any other form shall not be acceptable.
