Bihar State Educational infrastructure Development Corporation (BSEIDC), Patna invites application from eligible contractors for empanelment for the execution of Civil, Electrical and other Repair & Maintenance work related to schools, hostels, colleges, and other allied educational infrastructure across the State of Bihar.

For the purpose of this Request for empanelment shall mean the pre-qualification of eligible contractors for execution of works through limited tendering, quotation, or nomination procedures during the validity period of the empanelment.

The department doesn't take any responsibility for the delay/ non-submission of Tender/ non-reconciliation of online payment caused due to non - availability of Internet connection Network Traffic Holidays or any other reason.

The required amount of Earnest Money Deposit is acceptable either in the form of online mode or Bank Guarantee (BG) in proper format issued by any Nationalized/Schedule Bank issued in favour of MD, BSEIDC, payable at Patna. The original Earnest Money Deposit will have to be deposited along with the hard copy of bid document in the office of BSEIDC as per tender schedule, failing which tender will be rejected. The Earnest Money deposited in any other form shall not be acceptable.
